I am forwarding herewith the priority list of teachers of various categories for Inter District Transfer on Compassionate Ground to your District from other Districts. I request you to issue transfer orders to the teachers in due course. subject to the following conditions.

1. The formal transfer orders to the teachers against the vacancies in each category of teachers set apart for Inter District Transfer on Compassionate Ground (i.e 6% vacancies of H.S.A's and 7% of vacancies for P.D.Teachers from the net vacancies arrived as per the procedure laid down in GO 3<sup>rd</sup> cited issued according to serial No assigned in the list.
2. Transfer order need be issued to the teachers only if they have submitted formal transfer application for Inter District Transfer through proper channel. If the transfer application of any of the teachers included in the list is not

received in time the copy of same may be obtained from the Teachers through proper channel before issuing the transfer order.

3. If any of the teachers included in the list, has not completed a minimum period of 5 years at the time of transfer order issued in the District in which he/she is now working he/she should not be given transfer and the fact should be reported to this office. The minimum period of service is not required for Inter District Transfer to Wayanad, Idukki and Kasaragod.
4. In the case of H.S.A's the vacancies set apart for each subject/Languages should be filled up separately on the basis of priority in the list. Subject ratio should be maintained when transfer orders are issued.
5. Only vacancies set apart for Inter District Transfer on Compassionate Grounds alone should be filled up from the list. Other vacancies should be filled up by the methods prescribed in the G.O 3<sup>rd</sup> and this office Circular 5<sup>th</sup> cited.
6. If the name of any protected teacher crept in the list he/she is not eligible for Compassionate Ground Transfer.
7. A committee was constituted for selecting eligible candidates of priority list for Inter District Transfer on Compassionate Ground as per letter of even no dated 19/2/2010. The list is prepared on the basis of scrutiny of Medical Certificate submitted by the applicant.
8. This list will be in force till the publication of the next list for Inter District Transfer from this office. The vacancies (existing & arising) set a part for Inter District Transfer on Compassionate Ground should be filled up in the list.

9. Inclusion of name of a teacher in the list does not confer on him/her any right for getting the transfer.
10. Statement showing the details of vacancies set apart for Inter District Transfer on Compassionate Ground in each category, details of teachers transferred, copy of transfer etc. should be furnished to this office from all Deputy Directors on or before 31/7/2010.
