Loans and advances sanctioned to State Government Employees - Recovery during April 2010 postponed - Orders issued.

ORDER

Government are pleased to order that recovery on account of the repayment of principal and interest of all loans and advances taken from Government by the State Government Employees, drawing basic pay up to Rs.12,930/- (pre revised pay Rs.7,800/-) per month, from the salary for the month of April, 2010 will be postponed. The recovery of instalments thus postponed will be effected in five equal monthly instalments from their salaries for the month of July 2010 to November 2010.

The recovery of the deferred instalments should be effected strictly according to the above schedule, failing which the concerned drawing and disbursing officers will be held liable. The Treasury Officers should not honour bills which are presented without effecting recovery towards the postponed instalments.

These orders will be applicable to all State Government Employees including those borne on contingent and work establishment and to the teaching and non teaching staff of Aided Schools and Private Colleges who are paid from the Consolidated Fund of the State.

The benefit of this order will be extended to all Non-Gazetted and Gazetted Officers of the local bodies including contingent and work establishment staff drawing basic pay up to Rs.12,930/- (Pre revised pay Rs.7,800/-) per month in respect of the Loans and Advances taken by them from the local bodies concerned.
